Opening Business

7. Marketing/Advertising/Promotions (Jenn)

Jenn reported that we have a pretty good turnout for our Newcomer level. It was suggested that this may be in large part due to our Facebook ads.

We are contracting Chris Millington for our New Year's Dance at a cost of \$5,500. He is going to look into the cost of renting mauve lighting to have on the band. We will be using the same caterer as last year at a cost of about \$35 per person. After a brief discussion the following motion was put forward:

Doors will open at 7:30, with dinner at 8:00 p.m. Veronica will explore the possibility of having a wine company attend the event.

12. Pacifica Ball (Victor Golubkov)

Victor sent information to the board via email (see attachment) but was not able to attend the meeting. He requested a meeting with the board to discuss sanctioning. The time and date were set for 6:30 p.m. on September 25.

NDCC is currently in disagreement with DanceSport. A suggestion was made that we get official statements from the relevant groups regarding their stance on Pacifica Ball and sanctioning. Jenn will follow up on this.

Victor suggested two possible dates for Pacifica Ball: April 9 or June 18. April 9 seems better suited – there are no other competitions on that date, kids will still be in school, hotels will be cheaper, and it is after the VCCC and prior to Island Fantasy Ball. It could be a good warm-up for the latter.

The board felt strongly that there would need to be a VBDS board member on the Pacifica Ball Committee to act as liaison between the board and the Pacifica organizers. The designated member would attend meetings and voice the Board's concerns.

BUDGET PROPOSAL FOR VBDS "BALLROOM IN THE SCHOOLS" FALL 2015

This report proposes a preliminary budget for the VBDS "Ballroom in the Schools" Program for the Fall Term of 2015, requesting Board comment and approval.

Preliminary interest in participating in the Program this Fall has so far been expressed by five (5) schools in the Greater Victoria area. Based on past experience, it is not highly likely that all five of these enquiries will result in instruction proceeding this Fall Term (although the hope is that there may be follow-up resulting in classes in some, possibly with pilot programs of some kind, in the Winter or Spring Terms). Nevertheless, the Budget being proposed for this Term is based on providing us with the flexibility to proceed in five schools, should the preliminary arrangements we are working on prove to be feasible.

Budget Proposal: A budget with VBDS sponsorship of the "Ballroom in the Schools" Program being a contribution not to exceed \$1350 over the Fall Term of fiscal year 2015-16; this would allow VBDS to support up to 8 one-hour ballroom classes in each of **five** schools (or the equivalent; e.g. being in four schools, but with more classes during the Term).

If approved, the proposal is that the Program would continue much in line with guidelines used in past years: the Schools would be asked to provide the required space and supervision, and VBDS typically would cover up to 50 percent of instructor costs (the balance coming from different sources, depending on the school; e.g. PAC special funding, PE budgets, etc.).

In the past, schools in the Program have also been asked to assist with and support some form of public performance, to allow the students to demonstrate what they have learned in the classes. This also assists VBDS in support of its main mandate, of promoting an active interest in ballroom dancing, not only amongst youth, but with parents and the public more generally. We will again be seeking appropriate and innovative possibilities for such performances this year. Suggestions on this from the Board and from club members would certainly be welcome.

DECISION REQUESTED OF THE BOARD

The Board is asked to consider and approve a Motion along the following lines:

BE IT RESOLVED that the Board authorizes a net expenditure of up to \$1350 over the Fall Term of fiscal year 2015-16 to allow for sponsorship of Ballroom Dance classes under the terms of the VBDS "Ballroom in the Schools" Program.

Proposal to Board for Pacifica 2016:

- 1. Event date:
 - a. April 10, 2016
 - i. Pros:
 - 1. Reasonable weather, not too hot
 - 2. Between UBC Gala and Island Fantasy Ball
 - 3. More people in town and kids are still in school
 - 4. Very close to the end of the second session of VBDS classes, and 1 month after Closed Clubs Competition which gives momentum
 - 5. No other events around this date (CDS, NDCC, NDCA or USADance)
 - ii. Cons:
 - 1. Soon
 - 2. Close to Island Fantasy Ball (but before it)
 - 3. New event with a new date
 - b. June 18, 2016
 - i. Pros:
 - More time for planning
 - 2. More possible venues
 - 3. Close to the end of VBDS 3rd session
 - ii. Cons:
 - 1. Hot weather
 - 2. Less people in town, kids almost done school
 - 3. Possible other event in Vancouver
 - c. Why not historical weekend?
 - i. At the end of the competitive season
 - ii. Close to Island Fantasy (and after it)
 - iii. Hot weather
 - iv. Competes with events nearby in the US on the same day both WDSF and NDCC
- 2. Venue—multiple options are being explored, including Commonwealth Place and final decision will be made based on date, availability and cost, once a date is selected.

- 4. Plan for attracting Sponsors:

SPONSORSHIPS. Four levels of Sponsorship will be offered (from PB2015 discussions):

- i. Platinum sponsor (\$3000 a new addition):
 - a. ad positioning in the top half of the PB website;
 - b. full page colour ad in program,
 - c. board display on floor,

- d. ad presence on social medial, a chance to hand out awards,
- e. a Staff Master-class at VGdance studio,
- f. Four front row seats with dinner in the evening,
- g. Possible TV projector equipment which could project ad images on the walls or on TV screen at event.

ii. **GOLD (\$1250) includes:**

- b. Prominent advertisement on Pacifica website OR as a Board Display placed around the competition floor for the duration of the event,
- c. Two front row seats with dinner in the evening,
- d. Public acknowledgement of your support throughout the event,
- e. Acknowledgement opportunity for Medals and/or Trophies in Gold and Championship level events,
- f. 3 free private dance lessons at VGdance studio

iii. SILVER (\$900) includes:

- a. Half-page, colour advertisement in Souvenir Program,
- b. Advertisement on Pacifica Website OR as a Board Display placed around the competition floor for the duration of the event,
- c. Two front row seats with dinner in the evening and weekend event tickets for competitions,
- d. Public acknowledgement of your support throughout the event,
- e. Acknowledgement opportunity of Medals in Silver level events,
- f. 2 free private dance lessons at VGdance studio

iv. BRONZE (\$750) includes:

- a. Quarter page colour advertisement in the Souvenir program, AND an advertisement on our Website,
- b. Public acknowledgement of your support throughout the event,
- c. Two seats with dinner in the evening and weekend event tickets for competitions,
- d. Acknowledgement of Medals in Bronze level events,
- e. 1 free private dance lesson at VGdance studio

v. MEDAL SPONSORS: \$100

- a. Public acknowledgement of your support at the Medal presentation,
- b. There are 112 events in which Medals could be awarded—3 Medals per event

5. Sanctioning Decision—TBD, but considerations:

- a. DSBC
 - i. Pros:
 - Most competitors have current membership
 - 2. Supported by the competitors' community. (General community isn't concerned about two different organizations)
 - 3. There is a possibility if we ask for a closed championship we might be granted one
 - 4. Better promotional resources (DSBC website)
 - ii. Cons:
 - Less variety in events

- 2. More expensive officials as more are needed
- 3. Less income due to no pro/am and less amateur events
- 4. Doesn't support full community of amateurs, pros and pro/am students
- 5. Competes with Island Fantasy Ball
- 6. No American Style

b. NDCC

- i. Pros:
 - 1. More event variety. Ex: Single dance events for Amateurs.
 - 2. Possible to have pro/am so higher income from registrations
 - 3. Allows American Style
 - 4. Supports full community of amateurs, pros and pro/am students
 - 5. More possibility for having showcases to add value to event
 - 6. Doesn't compete with Island Fantasy Ball
- ii. Cons:
 - 1. Not all competitors belong to NDCC, so there is resistance from DSBC couples and coaches
 - 2. Not well supported by the community
 - 3. May have less competitors in Amateurs
 - Competitors having ongoing fear of being banned by DSBC despite Pinky
 Wong's posting and assurance on facebook that there won't be any sanctions
 or penalties if DSBC members dance in non-sanctioned event.
- 6. Budget—All budget numbers are reasonable estimates based on research and some limited historical data to give board members a chance to make a more informed decision. Decisions (such as venue and sanctioning) will have an effect on budget.
 - a. Expenses:
 - i. Venue—TBD, but estimate approximately \$3000
 - ii. Sound System—VBDS system?
 - iii. Decorations-\$750
 - iv. Catering—\$3000
 - v. Trophies-\$1000
 - vi. Equipment—TBD depending on venue choice and requirements
 - vii. Advertising—\$1000
 - viii. Judges travel—\$1000 per person
 - ix. Officials—\$500 per person (number will vary depending on sanctioning—DSBC requires a minimum of 9 officials, NDCC requires a minimum of 5)
 - x. Judges Accommodations—\$150 per person
 - xi. O2cm—\$550 maximum
 - xii. Top Competitors—\$2000-\$4000 depending on how it is done
 - Options include Belayev and Popova, Ruscinski and Velselkina, and Shalvarov and Profatilova (pro couple, Dance Comp Review for showcases)
 - b. Income—figures can be provided once historical PB budget information is provided:
 - i. Registrations—to be estimated based on historical data
 - ii. Tickets—estimated based on historical data and sell-out

- iii. Sponsorship—4 tiers—intent is to maximize sponsorship as much as possible to off-set costs
- iv. Fundraising—different options were explored by PB2015 committee and those will be revisited
- 7. Advertising—full use of social media, website as well as paid advertising and programs
- 8. Schedule of Event—TBD, but 1-day event only
- 9. Proposed Ticket prices—to be decided based on decisions for sanctioning, showcases, etc.
- 10. Planning schedule—Will be determined once decision is made on 16 Sept by VBDS Board
- 11. Equipment—TBD based on venue and requirements
- 12. Event Volunteers—To be canvassed from Dance community
