## **President's Report**

be \$35, with the exception that members who are joining for the first time, or former members rejoining after an absence of more than 1 year from the expiration of their last membership year, may have their memberships pro-rated, such that if they join after December 1 the fee will be \$45 for regular members and \$25 for the student/disability rate, and if they join after March 1 the fee will be \$25 for both the full rate and the student/ disability rate.

- b) ORDINARY RESOLUTION #2: Annual Decision on Appointment of an Auditor (submitted by the Board; the Board recommends Members support this Motion) BE IT RESOLVED that VBDS appoint no auditor for the 2015-16 fiscal year.
