- 1. Treasurer's Report (Thomas)
 - a. The Volunteer Bookkeeper is recommending Class Fees include GST
 - b. Update on VBDS Insurance quotes for 2017-18 (Bob) (see attachment)
 - b.i. Bob has contacted two insurance agencies regarding the upcoming renewal of the insurance and has asked for quotes from both. It was agreed that two quotes should be sufficient to begin, subject to possibly adding a third later.

 - c.iii. The Treasurer has spoken with the bank regarding GICs and he requires a letter signed by two Board members to proceed with the purchase of said GICs

 - a. Most Session 1 classes are over 10 attendees. Two classes have so far been cancelled due to class-registrations being too low to run.
