- 1. Treasurer's Report (Thomas)
  - a. Membership Dues for 2017-18:

MOVED by the Treasurer that at the 2017 AGM, the Board recommend approval of the following Ordinary Resolution #1, Setting Annual Membership Dues for VBDS

Be it resolved that effective immediately the annual dues for regular membership be set at \$70 per annum, and that the rate for eligible students and disabled persons be \$40, with the exception that members who are joining for the first time, or former members rejoining after an absence of more than 1 year from the expiration of their last membership year, may have their memberships pro-rated, such that if they join after January 1 the fee will be \$50 for regular members and \$25 for student/disability rate, and if they join after April 1 the fee will be \$35 for the full rate and \$25 for the student/disability rate.

b. Proposed resolution to appoint an auditor for the AGM **MOVED** by the Treasurer that at the 2017 AGM, the Board recommend approval of the Ordinary Resolution #2, Appointment of and Auditor:

Be it resolved that the VBDS appoint no auditor for the 2016/17 fiscal year.

c. Motion re: Development Fund transfer/s for 2016-17 Balance Sheet

MOVED by the Budget and Finance Committee that the Treasurer be authorised to
transfer an amount up to but not exceeding \$15000 from the VBDS Development Fund
to the VBDS General Fund operating account, and that, subject to further consultation
and advice from the VBDS Accountants, the VBDS Financial Statements for Fiscal Year

2016-17 be finalized accordingly, and be submitted to the Board at our November Meeting, for approval re circulation to the Membership. **Approved** 

- Volunteer Bookkeeper recommendation that class fees include GST. It was confirmed that the intention of the Board is indeed that the class fees do include GST
- e. Directions to VBDS accountants re: Finalising 2017-18 Financials
   MOVED by Treasurer for a budget up to \$1000 to finalise the Financial statements for 2016-17.

- f. Review of Proposed 2017-18 VBDS Budget a review of the proposed 2017-18 budget was presented, and a few revisions have been recommended to the Budget and Finance Committee
- g. The Treasurer has purchased the following GICs: \$25,000 valid 11 October 2017 until 11 October 2018 at 1.65% per annum. \$75,000 valid 11 October 2017 until 11 May 2019 at 2.25% per annum. \$30,000 valid 11 October 2017 until 11 September 2020 at 2.5% per annum; consequently, as authorized by the Board, VBDS now has a total of \$130,000 invested in GICs, with different terms
- 2. Standards & Classes Committee (Steve, Douglas, Bob)
  - a. The Standards and Classes Committee received further communication from the instructors regarding their fees and the Committee is further discussing the options
  - b. The Standards and Classes Committee proposes an increase in Class fees of at least \$1 per class--hour, beginning in 2018
- 3. Dance Committee
  - a. The New Year's Dance planning is in full planning mode, the caterers are confirmed, graphics are being produced, and the theme has been decided upon. It is agreed that the Dance Committee have the tickets available to members no later than two weeks prior to the AGM and be available to members only in November, and opened up to general purchase 1 December.
