Members of the committee are free to consult with other members of the board, members of the VBDS and the general public as they see fit.

- At *Doncaster Elementary School*, the plan for 2018 is that Wanda Kivitt will be overseeing 8 hours of Ballroom Dance classes, and 2 performances by Grade 3 and Grade 4 students. The performances are planned for the Performing Arts Festival in April (usually the last week), and at special school assembly for students and parents (usually in May). This year the students will be learning Paso Doble as the partner dance, and the Hustle Line Dance.
- At *Oak Bay High School*, Wanda will be teaching the Ballroom Dance Unit as part of the regular dance program at the school. We also hope to be able to re-start the *Ballroom Dance Club* at Oak Bay High again in 2018. This season we are looking at an 8 week course from January 23 to March 13 for students who join the Oak Bay Club. For a performance component, we are considering having the Club Members do a demonstration at a VBDS social dance (ideally in March, at our usual "Club Demonstrations"), and/or at a senior's residence in Oak Bay.
- We have also been approached by *Carlton House*, an independent living seniors' residence in Oak Bay, to help provide Ballroom Dance Lessons during day-time hours to residents. We are hoping to start on a trial basis twice a month in January and February. Depending on interest, we will likely start with partner dances Waltz and Foxtrot, with the possibility of doing Ballroom Line Dances if there is a significant imbalance of leads/follows. The programming at Carlton House will be organized on the basis of full cost-recovery for VBDS.
- The **Shoal Centre** in Sidney has also again expressed interest in securing our assistance teaching a series of Ballroom Line-Dance classes, and we will attempting to repeat the 2017 series again in 2018. This will also be done on the basis of full cost-recovery.
