- Finance report, income statement and balance sheet were circulated.
- Coast Capital Visa application: Coast Capital requires one of the signing officers to act as guarantor for the credit card. As signing officers will change periodically, it was suggested that Coast Capital be asked if it would be possible to arrange an offsetting deposit (e.g. small GIC) as guarantee.

Monthly dances

- Approximately 39 attendees at the Spring dance on Apr 21 at the Chief & Petty Officers mess in Esquimalt. Anthony Thompson provided the music (contemporary/ballroom).
- Approximately 38 attendees at the May 5 Newcomers Dance. Journey Hood provided the music (contemporary/ballroom). Was encouraging to see lots of new faces at the dance.
