1) **RESOLUTIONS:**

Ordinary Resolution #1: Setting Membership Dues for Victoria Ballroom Dance Society

BE IT RESOLVED that effective immediately, the annual dues for regular membership be set at \$70 per annum, and that the rate for eligible students and disabled persons be \$40, with the exception that members who are joining for the first time, or former members rejoining after an absence of more than 1 year from the expiration of their last membership year, may have their memberships pro-rated, such that if they join after January 1 the fee will be \$50 for regular members and \$30 for the student/disability rate, and if they join after April 1 the fee will be \$30 for the full rate and for the student/disability rate.

Special Resolution #1: Constitutional Amendment: to establish Victoria Ballroom Dance Society "Member Funded" Status

WHEREAS the new Societies Act provides that, "On transition, each pre-existing society will be asked whether it wishes to designate itself as a "member-funded society" by including a statement to that effect in its constitution";

AND WHEREAS "a member-funded society is a society that is funded primarily by its members to carry on activities for the benefit of its members", and VBDS would qualify as a "member-funded society" under the Act;

Special Resolution #2: Bylaw re: Amendments that are in order at General Meetings

BE IT RESOLVED that Clause 14.c.iii of the VBDS Bylaws be amended to read as follows: "(iii) the issue of whether an amendment to an ordinary or special resolution introduces an independent new question shall be decided at a general meeting by ruling of the chair, subject only to an appeal approved by 66%+1 of members present and voting."

Amendment by Scott Hamilton: to replace the words "by 66% + 1 of members present and voting" with the words "by 2/3 of the votes cast".

BE IT RESOLVED that Clause 14.c.iii of the VBDS Bylaws be amended to read as follows: "(iii) the issue of whether an amendment to an ordinary or special resolution introduces an independent new question shall be decided at a general meeting by ruling of the chair, subject only to an appeal approved by 2/3 of the votes cast." Special Resolution #3: Bylaw re: handling of questions of order

BE IT RESOLVED that Clause 23 of the Victoria Ballroom Dance Society Bylaws be amended to read as follows:

"23. Questions of order arising, if not otherwise provided for in these Bylaws, shall be decided by the chair, subject only to an appeal approved by 66%+1 of members present and voting."

Amendment by Scott Hamilton to: replace the words "by 66% + 1 of members present and voting" with the words "by 2/3 of the votes cast".

AMENDED MOTION:

BE IT RESOLVED that Clause 23 of the Victoria Ballroom Dance Society Bylaws be amended to read as follows:

"23. Questions of order arising, if not otherwise provided for in these Bylaws, shall be decided by the chair, subject only to an appeal approved by 2/3 of the votes cast."

Special Resolution #4: Approving the revised Victoria Ballroom Dance Society Constitution & Bylaws, as amended

BE IT RESOLVED that the revised Victoria Ballroom Dance Society Constitution & Bylaws, as circulated to the Membership prior to this 2017 Annual General Meeting ("Transition Draft #04"), and as amended at this 2017 AGM, be approved.

Ordinary Resolution #3: Possible Draw-down from the "VBDS Development Fund"

BE IT RESOLVED that the VBDS Board be authorized to draw-down the VBDS Development Fund Equity Account by an amount not to exceed \$5000 in 2018-19, if such is needed to responsibly fund an increase in instructor hourly rates, rate increases to exceed 2% but not to exceed 5% for 2018, over 2017 hourly rates.

MOVED BY: the Chair, Douglas Anderson on behalf of the board

Amendment by Sherman Waddell to: remove the words "not to exceed 5%" and replace them with the words "not to exceed 15%"

Amendment DEFEATED

Amendment to: remove the words "2018-19, if such is needed to responsibly fund an increase in instructor hourly rates, rate increases to exceed 2% but not to exceed 5% for 2018, over 2017 hourly rates" and replace with the words "2017-18 such as needed to responsibly fund an increase in instructor hourly rate".

BE IT RESOLVED that the VBDS Board be authorized to draw-down the VBDS Development Fund Equity Account by an amount not to exceed \$5000 in 2017-18 such as needed to responsibly funding an increase in instructor hourly rate.

Be it resolved that the \$10,000.00 "borrowed" from the Hodgson Fund be returned to the Hodgson Fund as the action was contrary to the Board Resolution of 22 October 2014 that established the Special Fund and which remains unchanged and effective.

Be it further resolved that the membership restricts the Board of Directors from making any changes to the Board Resolution of 22 October 2014 affecting either of the Special Funds without consulting the membership at a general meeting.

(a). Should such a person be teaching regular classes for the society they are eligible for membership as an Honorary Member in accordance with bylaw 4.(d)."

PRESIDENTS REPORT FOR THE 2017 VBDS ANNUAL GENERAL MEETING

Welcome everyone to the VBDS 2017 Annual General Meeting!

I would like to first take a moment to introduce your dedicated hard working VBDS Board of Directors who have all volunteered their valuable time and energy for you the membership! Thank You to Louise for her contributions with our VBDS Dances throughout the year and her many contributions during the VBDS Board Meetings! Thank You to Clare Martin who was our Secretary this year. This position has to be ready to respond the vast array of correspondence that the Board receives on a daily basis many times. Also Clare was always there at our Intro Workshops to make potential new members feel warmly welcomed! On top of that Clare was always willing to help in numerous volunteer opportunities. As a Board we have appreciated the many words of wisdom by Doug Anderson in our Board Meetings and communications throughout the year. Doug surprised us with a last minute role as an Instructor at one of our Intro Workshops which was invaluable and was very well received by all who attended! I fully recommend Doug for President in the upcoming year. Thomas Webber took on a very difficult task this past year as Treasurer and we appreciate all that he did to get our financials up to date and in order. I should mention also that Thomas and his partner Dianne have volunteered in many opportunities to promote VBDS. Last but no means least, I would like to thank Bob Adams for his massive contribution in the past 2 years and it is a big loss to the Board that he is not continuing as a Director. It is a huge shame that he is not appreciated by some members as much as he should be. Bob has tirelessly given up so much of his time and energy and even to the detriment of his health. His assistance to me as President over the past 2 years has been invaluable! Bob is an extremely valuable asset to the Governance Committee as Chair and for many years he has contributed hundreds of hours with the Youth & Outreach Schools Program!

Over the past 2 years we have turned the Club around from a declining membership of 60-80 members every year since 2008! This last year we increased the membership from 320 to 434 and we have seen a good rise in Class numbers! The Treasurers Report tonight will indicate that Classes are Up and Membership is up... Our loss is significantly down but unfortunately our Classes are still not contributing sufficiently to the overall running of the Club. We still do not have enough members registering in our classes which is our biggest area of shortfall, we will be discussing that later in the meeting.

We now have a Finance & Budget Committee in place, and for the first time in many years, we have an interim budget for 2018 ready for the new Board.

A new "Societies Act" came into effect last November, and this has some important implications for VBDS as a registered "Society" under the Act. Our Governance Committee has been focused on allowing us to file for simple "transition" as required by the new Act, planning to do so well before the deadline which is next November 2018, as we will be discussing later in the form of some "Special Resolutions" that are on the Agenda.

The Standards & Classes Committee is currently in active negotiations with our instructors on their contracts for 2018. This has a number of potential implications for the club, which will be discussed in connection with two of the "Ordinary Resolutions" on the Agenda.

Finally I would like to thank all of the support from such a large number of VBDS Members. I appreciate all of your positive remarks and support over the past 2 years. There was a vast amount of work that had to happen to make such a big turnaround possible and your words of encouragement were what kept me going!! I would respectfully like to point out that if it was possible to get about 40-50 people all doing a very small amount of work or duties the job of running this Club would be monumentally easier and we would be able to focus more time on many of the area's I was unable to accomplish!! To give you a clear idea what this would look like it would be as little as 30-60 minutes per month for about 9 months of the year. I will not be continuing on the Board after this coming year so if you would really like to show your appreciation please approach me with your open willingness to contribute with your availability and skills you can bring forward. Once again I would like to convey my deepest thanks to all of your positive support!!

PURPOSE OF THE SOCIETY

Victoria Ballroom Dance Society is a not-for-profit organization incorporated provincially under the Society Act of British Columbia. The purposes of the society are:

- To promote an interest in ballroom-dancing;
- To create a physical and social environment that encourages people to participate actively in ballroom dencing as a performing art, as a recreational and social activity, and as a competition sport;
- To provide instruction at a variety of levels of ballroom dancing;
- To provide social opportunities, workshops, and dances; and
- To encourage communication and friendship with other ballroom dance groups in the community, in the province, and elsewhere.
