7. Resolution regarding membership dues

MOVED by Michael that we bring forward an ordinary resolution to the 2021-2022 AGM TO SET MEMBERSHIP DUES FOR 2022-2023 year as follows:

BE IT RESOLVED that VBDS annual dues for regular membership be \$72 per annum, and that the rate for eligible students and members with disabilities be \$40 per annum for the 2022-23 membership year. Regular members joining after January 1, be prorated to \$52, student/members with disabilities prorated to \$30. Regular members joining after April 1, be prorated to \$32, student/members with disabilities \$30.

- a) MOVED by Lynne that we bring forward a special resolution to the 2021-2022 AGM TO AMEND VBDS BYLAW SECTION 30 (c) as follows:

BE IT RESOLVED that the VBDS bylaws be amended as follows:

The board recommends that Section 30 (c), which currently states:

A separate election shall be held at each annual general meeting to select the president from amongst those directors who wish to run for this office. This position shall be for a one year term.

Be replaced with:

A separate election shall be held at each annual general meeting to select the president from amongst those directors who express their wish to hold this office. The term of the president shall be for one year, from the end of the AGM in which they are elected to the end of the subsequent AGM.

b) MOVED by Lynne that we bring forward a special resolution to the 2021-2022 AGM TO AMEND VBDS BYLAW SECTION 32 (c) as follows:

BE IT RESOLVED that the VBDS bylaws be amended as follows:

The board recommends that Section 32 (c) which currently states:

If the president resigns his or her office or otherwise ceases to hold office, the directors shall appoint another director to fill the office until the next general meeting.

Be replaced with:

If the president resigns his or her office, or the position of president is otherwise vacant, the directors shall appoint another director to fill the office until the next general meeting.
