- 6. Business arising from the minutes

This was discussed and deferred to the January board meeting when the Treasurer will be present.

- Budget to promote Christmas dance on social media

Diane noted we have four practices per week and asked if we need more volunteers to run the music as we currently have only two. Brian noted that volunteers are using their own devices. Diane requested that the music committee look into this. Gerry and Lawrence volunteered to help with music. She noted we are expanding repertoire of line dances and

music.

- 9. Committee reports
 - a) Community Outreach: Michael has made the submission to the City of Victoria for Dancing in the Square 2024. Michael has also reached out to Mayfair mall regarding a VBDS demo.
 - b) Dance: Diane noted we will be giving out 4 \$25 VBDS gift certificates at the Christmas dance. She also noted the storage locker for all VBDS supplies is in dire need of proper containers for organization and transport. The dance committee requested funds for supplies. The amount of \$300 was discussed and deferred to the January board meeting when the Treasurer will be present.
 - c) Finance: No report.
 - d) Governance: No report.
 - e) Marketing and Promotions: Directors discussed notifying members about monthly dances and classes in separate notifications from the newsletter.
 - f) Membership: Lawrence reported that we have 104 regular members and 5 members who are students or dancers with a disability. Diane reminded directors that we have a long-standing agreement with Nanaimo Ballroom Dance Society to allow each other's members to attend dances at member's pricing.
 - g) Standards and Classes: Michael provided a financial review of classes for Session 2: Nov/Dec, indicating a profit for the session.

- a) Credit notes Some members have credit notes on file. The classes committee will meet to discuss how these will be handled and will report back in 2024.
- b) Submitting updated by-laws to BC Societies Jay to ask Michael to submit them.
- c) Rebranding initiative Many people have noted that VBDS logos and branding are looking outdated. A member who is a graphic designer has volunteered to create a package with rebranding suggestions. Diane will also provide a market analysis document to members. Rebranding can also be discussed at the January 6, 2024 brainstorming meeting. The problem of declining membership is not new.
